Midlothian Council believe that an extension to this debate needs to be initiated in our communities about access to sanitary products in toilets used by the public, such as public toilets, in bars and restaurants and other public buildings. Toilet paper, soap and hand towels are readily available in all publicly accessible toilets. Sanitary products should be viewed no differently from these products and as such, we call upon the Scottish Parliament to initiate a public consultation with a view to changing toilet regulations to ensure sanitary products are available at no charge in all toilets accessed by the public.
