Having products freely available in schools would allow younger girls to access them without having to get a card, which they may not know how to do.

The attainment gap is actually a poverty gap. Schools cannot close this gap alone. Societal change is also needed. Period poverty is one more barrier to education and educational achievement but one which only affects girls. Period products should be free in all educational establishments so girls and women can access them easily. There is anecdotal evidence of girls missing school because they have no sanitary products. This is unacceptable. In addition, girls can be anxious at school if they do not have sanitary products or if they are afraid they will run out. This, again, can be a barrier to learning. There will also be girls who are living in homes where there is domestic abuse. They can be afraid to ask for money or for these products. Domestic abuse can often include controlling behaviour so women and girls may be denied money.
