At school I would often need a new product frequently but didn't necessarily have anything on me as either I hadn't anticipated needing one that day or had already gone through everything I had on me. The machines in the toilets were rarely stocked or working and required exact change which I didn't necessarily have. I never felt comfortable approaching office staff as I was embarrassed.
