I assume that not everyone who may claim will use it for reasons of convenience and personal preference of products so the cost should not be prohibitive. However, it also helps any woman who may be caught short ... The limitation of how much can be used would stop an abuse of the scheme (e.g. people reselling or wasting products) . (I assume here that there will be a generous allowance, as some women experience heavier periods than others). However, should research show that there is no danger of larger scale abuse of the scheme, then I would be happy with unlimited access.
