This would be much much greener than providing pads and tampons, and would be much cheaper to administer as a policy. There are a variety of pads, cups and sponges available on the open market and I think the government should look at these as a better alternative to the card-based system as they would be a one-off issue, that would last for several years per client. I have to say, I'm always surprised that no-one else ever seems to even think of this as a possible solution....
