I work as a debt and benefits adviser for my local CAB so I see clients in need on a regular basis and now routinely ask if sanitary products are required when foodbank referrals are made. I have two daughters, aged 17 and 11. They both attend school or college and I think it is entirely appropriate that free sanitary products are available to anyone who may need them. I also believe that there needs to be a national discussion highlighting the effect on girls and women experiencing periods which results in absence from school, college, university or work as this leads to gaps in education and issues with employment which puts them at a distinct disadvantage.
