Free condoms are not means tested, therefore, free sanitary products should not be means tested. Not everyone takes advantage of free condoms, therefore, it is very likely that not everyone will take advantage of free sanitary products. I don't take advantage of free condoms but I can afford to buy them and think most people will think the same way...albeit there will always be people who take advantage hence setting a limit is sensible. Although that limit shouldn't be rigid as some women have heavier periods than others so should, 't be denied in those circumstances.
